1. The said school agrees to pay said official(s) the amount stated above for services.
2. This contract shall be null and void: (1) If either the school or the official becomes suspended from the NSAA; (2) If due to a merger, consolidation, school closing or cooperative sponsorship, the school ceases to have a program in the activity for which the contract was written; (3) If a high school cancels its entire schedule in the sport for which the contract was written prior to the date of first permitted contest; (4) If an official has been convicted of any crime involving moral turpitude or has committed any act which subjects the NSAA or its member schools to public embarrassment or ridicule.
3. If substitution of an official is necessary, contract is void unless mutual consent for substitute is received from competing schools.
4. If either party fails to fulfill the obligation of any part of contract, that party shall pay the other party a sum equal to the contractual gross fee, less mileage, as damages, and the breach of contract shall be reported to the Association.
5. This contract becomes invalid if not signed and returned by the official on or before
